



# House and Use Regulations

## Landesmesse Stuttgart GmbH (LMS)

### 1. Right of access/house right

- 1.1. The hall area of the new Stuttgart trade fair venue is not open to the public.
- 1.2. Landesmesse Stuttgart GmbH (LMS) exercises the house right in the entire trade fair venue (incl. the Messepiazza area) through the persons appointed by it for this purpose. In the event of infringements of these house and use regulations LMS reserves the right to impose a limited or unlimited exclusion from the property on the relevant persons.
- 1.3. Only such persons will be admitted to events in the trade fair venue as are certified by LMS and/or the respective organiser. Only those persons may be present in the trade fair venue who can show a valid authorisation pass or a valid ticket.
- 1.4. The visitors to events are only admitted to the trade fair venue during the opening hours of the events and must leave the trade fair venue at the end of the opening hours.

### 2. General prohibitions

- 2.1. Commercial photography, films, making audio and video recordings and drawings, in particular of exhibition stands and exhibits, is forbidden in the trade fair venue. Exceptions require the written permission of LMS.
- 2.2. Smoking is prohibited in the exhibition area. The only exclusions from this are the areas specifically allocated for this purpose.
- 2.3. Young persons, who have not yet reached the age of 14, may only be present in the trade fair venue in the company of a child minder or an equivalent supervisor. Exceptions will apply only with explicit notice at the tills.
- 2.4. The entry of the exhibition area by persons with inliner or other roller skates, skateboards, pedal scooters and other mobile devices, bicycles, electrical scooter or mobile tables is generally forbidden, however, exempt from this regulation are medically indicated wheelchairs.
- 2.5. The distribution of printed matter, as well as the posting of advertising stickers and posters and the unauthorised use of advertising media in the trade fair venue are not permitted without previous written permission from LMS. Exhibitors will be subject to a separate regulation, which refers exclusively to the exhibition stands.
- 2.6. Fireworks as well as other pyrotechnic products may not be let off in the trade fair venue; handling fire and open flame is forbidden.
- 2.7. Staying overnight in the trade fair venue (incl. the Messepiazza area) is not permitted.
- 2.8. The introduction of animals is permitted only with permission of LMS; an exclusion from this is made for guide dogs. If consent is given, then the person bringing in an animal must ensure that dangers or disadvantages are not caused for LMS or a third-party. In any event, however, it is forbidden to let animals run around freely.
- 2.9. Begging and hawking in the trade fair venue (incl. the Messepiazza area) are not permitted.
- 2.10. Any commercial activity in the trade fair venue without previous written permission of LMS is forbidden, without prejudice to the right to participate as exhibitors or visitors in events in the trade fair venue.

- 2.11. The carrying of weapons as well as compulsorily notifiable items and substances of any kind is forbidden in the trade fair venue, unless LMS has given special written permission.
- 2.12. LMS is entitled to check vehicles, bags and other containers as well as clothes of persons who enter the trade fair venue, for safety reasons, for their contents. LMS is entitled to prohibit for safety reasons the carrying of bags and similar containers in certain areas of the trade fair venue and/or at certain events.
- 2.13. Any contamination and environmental pollution and/or damage within the trade fair venue are to be avoided.

### 3. Vehicle traffic

- 3.1. Entry into the trade fair venue is permitted only for authorised vehicles which have a valid entry permit of LMS.
- 3.2. The written entry permit must be displayed clearly visibly behind the windshield of the vehicle concerned. LMS is entitled to tow away vehicles which do not display a visible entry permit.
- 3.3. On the entire trade fair venue the regulations of the Road Traffic Act (StVO) are generally applicable.

### 4. Liability and final provision

- 4.1. LMS and its employees/agents will only be liable for losses to the extent that they are due to deliberate or grossly negligent behaviour of these persons and/or the legal representatives of LMS. This limitation of liability does not apply, however, as far as concerns damage of injury to life, body or health which are based on a culpable action of LMS and/or the aforementioned persons.
- 4.2. The individual provisions of the present house and use regulations apply independently. The invalidity of one provision will not affect the validity of the other provisions.
